<u>Various</u>: The nurse has been directing potential members to the Center.

GSA has published fitness items in their tenant newsletter.

The new yoga instructor is excellent. John Burt spoke highly of her.

There was some brief discussion of the possibility of extending Center hours. The cleaners require sufficient time with the Center closed to perform their duties and leave by 8:30 PM.
